The Empty Container Storage Free Working Stock Scale mentioned in the referenced announcements has been updated as attached.

The application conditions of our announcement will be as follows:

- 1- The below updated scale will be valid for the contracts signed on 01.04.2015 and for the contracts will be signed after this announcement.
- 2- The Customers who doesn't have an Empty Container Storage Contract can apply until 1<sup>st</sup> September 2016. The contract commencement date will be 01 April 2016 for these customers
- 3- Transhipment containers (both discharging and loading movements) will be counted in the commitment of Empty Container Storage Free Working Stock.
- 4- Storage of transhipment empty containers will be subject to as per published "MIP Price List and Specific Conditions" and will be evaluated apart from Empty Pool (Monthly Storage Free Working Stock).
- 5- The Shipping Lines/Owners/Shipping Agencies (Separate application to be done for each Line represented by the same Agency) are required to sign a 2-year agreement by having stated their selected annual volume commitments.
- 6- The Empty containers benefiting from free stock application should return the port after gate-out and loaded to the vessel. Otherwise, tariff will be applicable on the said container's empty status.
- 7- Nomination of the empty containers will be made by MIP.
- 8- A monthly count of the TEU/Days will be tabulated at the end of each month. For excess of TEU/Days in each month, a charge of USD 2.5 per exceeding TEU-Day applies.
- 9- Container lines having signed 2 year Empty Container Storage Free Working Stock contracts with MIP will be able to transfer +/-5% of total yearly container volumes between the contractual years in order to fulfill the commitment in the agreement.
